

#### **Annual Activities Report: Community Safety Scotland**

#### **Injury Surveillance – New Report**

RoSPA Scotland has released a second statistical report entitled "Bridging the gap: injury surveillance in Scotland's Local Authorities". The document is an analysis of currently available data focussing on home injury rates in Scotland. It focusses on hospital admission rates in the home only.

## **Button Cell Batteries Report**

### Whirlpool

RoSPA welcomes Whirlpools decision to recall a number of tumble dryers. It is estimated that up to 800,000 unmodified tumblers dryers pose a potential fire risk in the UK.

The recall covers all models of vented and condensing tumble dryers produced between April 1, 2004 and September 30, 2015 and sold in the UK under the Hotpoint, Indesit, Creda, Proline and Swan brands. #### **Avoidable Deaths stalled in Scotland**

The British Medical Journal have released a new article which shows that avoidable deaths in the UK fell significantly in 2017 due to trends in England. Scotland had higher rates of avoidable deaths and failed to show in decreases with statistical significance.
