Salus - The Goddess of Safety and Wellbeing

The concept of safety has always been paramount within humanity. A good example is through looking at ancient Roman culture. Salus was the Roman Goddess of safety and welfare for both the state and individual. She had a temple dedicated to her in 302 BC. She is sometimes identified with the Greek Goddess Hygieia – the Goddess of health, hygiene and cleanliness.

Salus was provided offerings for the safety of the city of Rome and also for the health and fertility of the entire Roman community. She is typically represented with a snake and offering plant as well as with salt which in ancient roman culture was associated with good health.

Inquiry into decent and accessible homes for older people

This report from the All Party Parliamentary Group in England highlights the evidence showing the link between poor housing conditions and the impact on falls and other accidents. It also mentions that *many older people are forced to spend longer periods in hospital because their homes are unsuitable or ill equipped to allow them to be discharged.* The report relates specifically to England but there are similarities with Scotland.

Value for money: A recent systematic review has found that for every £1 spent on public health interventions, there was an average £14 of benefit to wider society.
