Cross Party Group on Accident Prevention and Safety Awareness

The Cross Party Group (CPG) on Accident Prevention and Safety Awareness has now been meeting for over six years and has gone from strength to strength. Convened by Clare Adamson, MSP, a very broad range of safety related topics is considered at the meetings and the average attendance number is 45. The membership consists of a wide variety of organisations with an interest in safety: either in the home, on the road, at leisure, or at work - or all four. RoSPA staff provide the Secretariat to the CPG and, following the business of the meetings (including the Secretary's Report and the opportunity to share news in the Headlines Newsletter), members can hear from three speakers relating to the theme of that particular meeting. Additionally, members are invited to be considered to 'pitch' a three minute presentation for future consideration by the Group.

Blind Cords

Five years after the new standards were introduced regarding the manufacture and fitting of blind cords there is still concern that there are many blinds out there, especially in children's bedrooms, that were fitted before the changes and therefore may not be safer by design. RoSPA recently completed research which showed, of homes which have blinds in the child's bedroom, one in three (33 per cent) were fitted more than five years ago.





In living rooms and hallways this figure rises to 38 per cent, and to 41 per cent in kitchens. Nearly one in three homes (29 per cent) have no safety devices fitted on their blinds.

RosPA urges parents, grandparents and carers to remove looped cords from their homes – particularly from children's bedrooms – and have new blinds fitted. If this is not possible, there are cheap or free safety devices which can be fitted, such as cleats, which enable the blind cords to be tied up. Luxembourg

Elizabeth Lumsden, RoSPA's community safety manager, attended EUSafety19 in Luxembourg from $3^{rd}-4^{th}$ October. The title of this event, which runs every two years, was "research for enhancing impact of strategies and actions". The conference – on Injury Prevention and Safety Promotion - built on the series of European Injury Prevention Conferences successfully organised over the past decades by EuroSafe and the success of the World Safety Conferences attended by a large European contingent.

Keynote speakers included a very interesting presentation from Nicholas Ward, Professor of Mechanical Engineering, Montana State University, USA, who emphasised the importance of "The role of culture in safety".

As well as delivering a presentation on Water Safety Policy in Scotland following RoSPA's recent research findings from across Scotland, Elizabeth also moderated several of the sessions on a variety of topics. The event in 2021 will be held in Vienna.
