#### Scald prevention and first aid research

RoSPA, East Renfrewshire Council and Care of Burns in Scotland (COBIS) teamed up to research and explore the prevalence of scald injuries, and the current understanding of knowledge of scald prevention and first aid among parents in East Renfrewshire, Scotland. The research which took place in 2019 reinforces the high risk of scald injuries to children in the home and the need for ongoing preventative messaging and projects in this area. #### **National Home Safety Committee**

The National Home Safety Committee met virtually on Wednesday 3<sup>rd</sup> June. Liz attended this meeting representing RoSPA in Scotland. Home Safety Scotland is also a member and was represented on the day by Hannah Dickson. The Minutes of the Meeting will be available in due course but information discussed included the concerns around the safety of electrical beauty products and the chargers that often go with them. There was also a really interesting presentation from the BBSA (British Blind and Shutter Association) looking at the myriad of excellent work that has been carried on this topic in recent years. However, there are still unsafe blinds out there and folks that are unaware of the risks as sadly children are still dying because of this preventable issue. A Blind Cord Safety Focus Group is being set up to consider the next steps.
