What is involved in Course Assurance?



Technical content and compliance

We will check that your course content is:

- Consistent with current legislation and cross referenced to relevant regulations, approved code of practice (ACOPS) and guidance notes
- Appropriate with industry and/or ethical standards.

We expect your organisation to ensure final versions of your course programmes:

- Are accurate
- Have correct spelling, punctuation, grammar and formatting
- Have correct house style and use of colours.

Additional checks for face-to-face delivery

If the course is delivered face-to-face, we will expect the trainer(s) to have occupational competence in the subject area, evidence of up-to-date CPD and have an adult training qualification at Level 3 on a regulated qualifications framework (RQF); OR have extensive proven experience delivering high quality face-to-face training.

Please note: some specialist courses may have different requirements.

A member of the RoSPA Qualification Course Assurance team will attend the course delivery, this will be undertaken virtually where possible, for example using Microsoft Teams or WebEx.

What is involved in Course Assurance?



Quality Assurance

Our quality assurance team will carry out a range of monitoring over the 2 year duration of your Course Assurance term and provide ongoing support and advice.

Monitoring will include how you advertise your courses, the correct use of RoSPA's logos and that you are adhering to the Course Assurance terms and conditions. It's also an opportunity to review any amendments you have made to existing programmes to ensure they still meet our Course Assurance criteria.



Submitting your courses for Course Assurance



The first step in the Course Assurance journey is to submit details of your courses using the Course Assurance Enquiry Form. Following receipt of this, your courses will be considered by RoSPA Qualifications, and once confirmed this will be followed up with a proposal/and or booking form.

Following submission and confirmation of your booking, you will be required to access our Qualification Management System (QMS) to submit a Course Assurance application form. RoSPA Qualifications will request access to your E-Learning platforms or course material as appropriate, to begin the course assurance review. For face-to-face courses, a date will be arranged for a member of the team to virtually attend your course.


Following the course review, you will be provided with a report of findings/recommendations accessed via the QMS. If there are actions, you will be required to complete them and send evidence before Course Assurance is awarded.

Once Course Assurance is awarded, you will receive your certificate and logo that will be valid for 2 years.
