

# **Information for Firework Display Organisers**

# **Licensing & Legislation**

#### **Did You Know?**

- It is against the law to carry fireworks in public if you're under 18
- Fireworks must not be sold to anyone who is under 18
- It is an offence to let fireworks off during night hours (11pm to 7am), except on Bonfire Night (midnight), Diwali, New Year, and Chinese New Year (1am)
- It is an offence under the Explosives Act 1875 to tamper with or modify fireworks.

## **Display Success**

- Remind the public not to bring their own fireworks to the event
- Keep sparklers away from fireworks by having a separate area cordoned off. Do not give sparklers to under-5s and wear gloves when handling them. Ensure spent sparklers are out by putting them in a bucket of water
- Good publicity is essential. If possible, appoint a publicity officer who will be in charge of press and advertising the event. Distribute flyers/posters around the local area
- Have other events during the display like competitions, fancy dress, a licensed bar, hot food, disco etc
- Merchandise can raise money for a good cause and add atmosphere
- Following this guide can help make your event safe and fun. But remember FIREWORKS ARE EXPLOSIVES – GET WISE OR GET HURT.

### **Did You Know?**

- All category 3 fireworks (display fireworks) must not exceed 120 decibels.
- If you supply or sell fireworks, you should be aware of your responsibilities which can be found in the Retailer's Guide: Selling fireworks.

# Ready... Steady... Go!

To have a successful and safe fireworks display, you should start planning at least three months beforehand. Follow our handy checklist to see what you should be doing when!

### Three months to go!

### Start planning now! At this stage have you...

- O Decided what kind of display you want and how many people you expect to attend
- O Agreed on a budget one for the fireworks and another for any additional activities
- O Decided what other events you want to have at the display and applied for the necessary licences.
- Appointed your firing team
- O Identified a site taking into consideration how much space you will need
- Obtained adequate insurance
- Enlisted the help of volunteers
- Arranged first aid cover?

### Two months to go!

#### You should...

- Apply for a licence your application could take up to six weeks, so apply for it now to make sure you get it in enough time \*Applies to Northern Ireland only
- Plan the firing script for the display
- O Decide what fireworks you will need to buy
- O Gather together the safety equipment you will need
- Book specialist equipment.

#### Three weeks to go

- O Time to buy your fireworks go to a licensed supplier
- Only buy fireworks that carry the CE mark
- O If your supplier does not have what you need, order them now
- Read the instructions carefully
- O Store the fireworks in a dry, secure place
- O Check that you have all the necessary entertainment licences
- Practise the firing schedule.

## Two weeks to go

- O Brief your volunteers on the schedule
- Assign each person with his or her own job

- Plan the site layout
- O Contact the relevant people so they are aware of your display
- Start publicising your event go to the local media, put up posters, hand out flyers, anything to spark interest!

### One week to go

- O Have a dummy run and make sure all your volunteers know what their jobs are
- O Check the fireworks for damage again if any are damaged, dispose of them safely
- Confirm the entertainment
- O Work out the safety plans in the event of an emergency
- Practise the firing schedule again.

### The day before

#### Now the hard work starts!

- Set up the site
- O Cordon off the different areas in preparation for tomorrow
- O Have a final meeting to brief the volunteers one more time
- O Practise the firing schedule one last time.

### On the day

- O Bring your licence with you \*Applies to Northern Ireland only
- Set up the fireworks in daylight put the last firework in place about 30 minutes beforehand if possible and cover them with plastic bags to keep dry
- O Remember your safety equipment and clothing
- O Keep spectators away from the site and guard the fireworks when in place
- After the display pick up the spent fireworks
- Douse the duds in water
- O Pack away all the paraphernalia
- O Come back the next day to clear the site.
