

RoSPA's 2019 Home Safety Congress took place at the National Space Centre, Leicester on Wednesday 27th February. Following an introductory message from Kelly Tolhurst MP for Rochester and Strood and an overview from the Office for Product Safety and Standards, main speakers included:

- Errol Taylor, Chief Executive, RoSPA: Safe and Active at all ages: A national strategy to prevent serious accidental injuries in England
- David McGown, Assistant Chief Officer and Director, Scottish Fire and Rescue Service: Building Safer Communities in Scotland
- Helen Jones, National Investigator, HSIB: Introduction to the Healthcare Safety Investigation Branch

Delegates then broke into two tracks:

- 1 Child in the home (including RoSPA Scotland's work on Home Free: A report on children's views on safety in the home)
- 2 Older people in the home

Cross Party Group on Accident Prevention and Safety Awareness

The first meeting of 2019 was held on 23rd January. The topic was '3 Minute Pitches' and members were given the opportunity to deliver a three minute presentation on a key priority, campaign or initiative that requires support or is lacking in their area of work. The presentations were followed by workshop discussions and the collated responses are now being considered.

Keeping Kids Safe in the Home



RoSPA Scotland are planning a new project in the Edinburgh area along with NHS Lothian and the Family Nurse Partnership thanks to some funding from the Safer Communities Division, Safer Communities Directorate in the Scottish Government. The project aims to provide parents and carers of children under the age of five with simple advice and information to help them keep their little ones safe from accidental harm.

The project will also focus on detailed research to explore with parents how they respond to and use the messages and equipment provided and how this impacts on their ability to make informed decisions on injury prevention.

The project is still in the initial stages but is hoped to be launched in the next few months.

The use and regulation of fireworks in Scotland

In November last year, the Scottish Government announced it would be taking forward a public consultation on the use and regulation of fireworks in Scotland. The consultation is now live and will run for a period 14 weeks, closing on Friday 10 May.

During the consultation the Scottish Government will seek views on how people use and enjoy fireworks, the impact they have on people and communities across Scotland, as well as their impact on animals. It will seek views on the sale of fireworks to the general public, and ideas on what action can be taken to ensure fireworks continue to be enjoyed safely and responsibly.

While much of the current legislation on the sale of fireworks is reserved to Westminster the consultation will help to identify gaps, issues or unintended consequences with the current regulatory framework.

Alongside the consultation there will be running a series of engagement events to create opportunities for members of the public, alongside local partners, to deliberate on the key issues and discuss with others what could be done going forward. RoSPA/RNLI Water Safety Policy Workshop

In 2018, RoSPA released "Local Authority Approaches to Managing Water Safety – Scotland Five Years on". This was a five-year follow-on study from the original research, which took place in Scotland in 2013. The aim of this was to provide an up-to-date analysis of how local authorities were managing water safety. Overall, as in 2013, a mixed picture was found. Several local authorities were addressing water safety but there was still very little consistency or uniformity.

In response to this research and to help implement Scotland's Drowning Prevention Strategy in Scotland, RoSPA and RNLI agreed to hold the very first policy orientated workshop with the aim to help local authorities understand water safety policy, the barriers to implementing a policy and to share key information and advice.

Supported by the Scottish Community Safety Network and Water Safety Scotland, the workshop hopes to help local authorities gain a better understanding of water safety policies and their benefits.
