

Scottish Government Consultation - Progressing Children's Rights in Scotland - An Action Plan 2018-21

The Scottish Government is keen to seek the views of all those with an interest in children's rights on the proposed content of the Action Plan for taking forward the rights of the child over the coming 3 year period, 2018-2021. A consultation is now **open until 26**th **September**.

For information, the wording of Article 24 of UNCRC is set out below -

- 1. States Parties recognize the right of the child to the enjoyment of the highest attainable standard of health and to facilities for the treatment of illness and rehabilitation of health. States Parties shall strive to ensure that no child is deprived of his or her right of access to such health care services.
- 2. States Parties shall pursue full implementation of this right and, in particular, shall take appropriate measures:
- (e) To ensure that all segments of society, in particular parents and children, are informed, have access to education and are supported in the use of basic knowledge of child health and nutrition, the advantages of breastfeeding, hygiene and environmental sanitation and the prevention of accidents;

This document is intended to be a foundation for the whole system, for public services, third sector, community organisations and others, to work better together to improve Scotland's health, and to empower people and communities. It is a starting point for new preventative approaches, and a new awareness around wellbeing, that will develop and strengthen in the coming years.

Priority 1

A Scotland where we live in vibrant, healthy and safe places and communities

Priority 2

A Scotland where we flourish in our early years

Priority 3

A Scotland where we have good mental wellbeing

Priority 4

A Scotland where we reduce the use of and harm from alcohol, tobacco and other drugs

Priority 5

A Scotland where we have a sustainable, inclusive economy with equality of outcomes for all

Priority 6

A Scotland where we eat well, have a healthy weight and are physically active




NRS data release

The main points for 2017:

- 2,348 deaths registered as accidental in Scotland, accounting for four per cent of the total deaths for that year.
- This is an increase of 132 accidental deaths (6%) compared with 2016.
- The most common cause of accidental death in Scotland in 2017 was falls (982 deaths, 42% of all accidental deaths).

Adverse Childhood Experiences and unintentional and intentional injury in later adulthood

This interesting study from the USA examined the link between Adverse Childhood Experiences(ACEs) and unintentional and intentional injury in later adulthood. It found evidence to support the theory that physical abuse and emotional neglect tended to lead to unintentional injury.
