

Testing the SCSN Framework

RoSPA has been part of Building Safer Communities evaluation framework group, which was taken forward by The Scottish Community Safety Network (SCSN) and Evaluation Support Scotland (ESS). The group aimed to look at developing an evaluation framework to support practitioners in measuring the impact of their work to tackle unintentional injury.

RoSPA, as part of this development, agreed to test the evaluation framework with its workshop on the management of water safety in Scotland's local authorities. The workshop links well to the evaluation framework. The prevention activity which is relevant to this workshop is **professionals, partners and service providers.**

A follow up report will be made available by October which will look at the medium term outcomes of the workshop.

The new style of meetings includes the opportunity for members to submit three-minute pitches. There will be four pitches heard at the meeting from Water Safety Scotland, GIST Limited, SSERC and Play Scotland.
